

# **Mitsubishi Electric – ‘Win a \$5,000 Winter Escape’ Promotion**

## **TERMS AND CONDITIONS**

### **1. General**

Your participation in this ‘Win a \$5,000 Winter Escape’ Promotion with Mitsubishi Electric (hereby referred to as the “Promotion”), run by Black Diamond Technologies Limited (BDT), the exclusive distributor of Mitsubishi Electric products in New Zealand, is governed by the following Terms and Conditions. By participating in the Promotion, you acknowledge that you have read and agree to be bound by these Terms and Conditions.

### **2. Promotion Summary**

To enter, purchase a qualifying Mitsubishi Electric LN Black Diamond Smart Series Heat Pump System from an Authorised Dealer between 1 June 2025 and 31 July 2025, and complete the official entry form by 31 August 2025 for a chance to win a \$5,000 travel gift card.

### **3. Eligible Purchases**

To be eligible for entry, the following conditions must be met:

- a. Purchase a qualifying model, these include MSZ-LN25/35/50/60VG(2/3)(R/V/B)(HZ) single split systems (OmniCore Multi Room Systems are excluded).
- b. The heat pump system must include a matching indoor and outdoor unit.
- c. Purchases must be invoiced within the promotion period (1 June 2025 to 31 July 2025). Installation delays will not affect eligibility, provided the order meets all other criteria.
- d. Only purchases from Authorised Mitsubishi Electric Dealers are eligible. This includes installers or retailers approved by BDT as part of the Authorised Mitsubishi Electric New Zealand dealer network.
- e. Purchases must be paid in full and not refunded, exchanged, or cancelled. If a winning entry is based on a returned or cancelled purchase, the prize will be forfeited and a new Prize Winner will be drawn.

- a. Purchase a Mitsubishi Electric LN Black Diamond Smart Series Heat Pump System between 1 June 2025 and 31 July 2025 from an Authorised Mitsubishi Electric Dealer.

This must clearly show the model purchased, the purchase date, and the name of the Authorised Mitsubishi Electric Dealer.
